The Forum this year expects to gather and connect in-person activators, expats, scholars from local and international higher education institutions and organizations to create a borderless environment to discuss the importance of International Branch Campuses (IBC) in the context of emerging countries.

By breaking down geographical barriers and promoting cross-cultural exchange, these campuses create opportunities for students to develop a global perspective and acquire skills needed to thrive in an interconnected world. Moreover, they play a crucial role in driving research, technology transfer, and entrepreneurship, contributing to the

development of a more inclusive and globally minded workforce capable of addressing complex challenges and seizing opportunities on a global scale.

The seventh Annual Forum on Internationalization of Higher Education (FIHE) aims to bring together a diverse group of stakeholders, including educators, researchers, policymakers, and industry experts, to discuss and advance the conversation on international branch campuses. - 8. **Addressing Brain Drain:** By offering globally recognized degrees and growth opportunities locally, international branch campuses help retain talent in emerging economies, mitigating brain drain and contributing to socio-economic development.

Authors are invited to submit their full papers (in English) in WORD, no later than September 20, 2024, to <a href="mailto:qhqt@ftu.edu.vn">qhqt@ftu.edu.vn</a>.

All submissions are required to include the following information on a separate cover page: title of paper, name(s) of author(s), organizational affiliation(s), e-mail addresses, and telephone number of the lead author.

Accepted papers will be published in Proceedings of the Forum with an ISBN number unless authors request otherwise. The forum organizers, in consultation with the Editors of Journal of International Economics and Management (ISSN 2615 - 9856), will invite the authors of high-quality papers to submit their manuscripts to the Journal.
